Fords Cookiepolicy

På Ford använder vi teknik som cookies och lokal lagring för att göra våra webbplatser enklare att använda och skräddarsy innehållet så det blir mer relevant för dig. Här förklarar vi vad cookies är samt syftet med att använda dem på Fords webbplatser.

Vad är en cookie?

Nästan alla webbplatser använder cookieteknik. En cookie, som ibland också kallas kaka, är en liten fil som sparar Internetinställningar. Den blir nedladdad genom en webbläsare under det första besöket på en webbplats. När du kommer tillbaka till sajten nästa gång med samma enhet, kan webbläsaren kontrollera om en nära anknuten cookie finns (d.v.s. som innehåller sajtens namn) och använda uppgifterna inuti cookien för att skicka tillbaka till sajten. Detta gör att sajterna kan känna av att webbläsaren har varit där på besök tidigare, och i vissa fall variera sitt innehåll för att återspegla det.

Vilka cookies använder vi?

Kategori 1 – Nödvändiga cookies

Dessa cookies behövs för att du ska kunna använda sidan och dess funktioner. Utan dessa kan flertalet funktioner på siten inte fungera.

MUID	1 year	Used widely by Microsoft as a unique user ID. The cookie enables user tracking by synchronising the ID across many Microsoft domains.	Microsoft

Kategori 2 – Prestandacookies

Prestandacookies samlar in data över hur besökare på ford.se använder sidan. T.ex. talar de om vart våra besökare oftast klickar, om de får felmeddelanden osv. Dessa cookies samlar inte in någon data som identifierar besökaren. All information som samlas in är anonym. Denna data används endast för att förbättra hur den här sidan fungerar.

_ga	2 years	Google analytics, _ga används för att förstå hur besökaren navigerar runt på webbplatsen	Google
CLID	1 year	Used by Microsoft Clarity. The cookie is set by embedded Microsoft Clarity scripts. The purpose of this cookie is for heatmap and session recording.	Microsoft



Kategori 3 – Marknadsföringscookies

Marknadsörings-cookies används för att leverera mer relevanta annonser anpassade för dina intressen. De används också för att begränsa hur ofta du får se en viss annons och mäter hur effektiva dessa annonser är. Annonserna publiceras oftast via ett annons-nätverk som kommer ihåg din webbhistorik, och denna information delas i nätverket. Ofta är dessa cookies kopplade till funktionalitet på hemsidan som levereras av en tredje part. Vissa av våra sidor kan innehålla bilder kallade Web Beacons som låter oss räkna antalet användare som besökt en sida. Dessa samlar bara in begärtsad information som cookie-nummer, datum och tid samt en beskrivning av sidan. Vi kan också använda Web Beacons från tredje part marknadsförare. Dessa innehåller ingen personlig information och används endast för att följa hur effektiv en viss marknadsföringskampanj är.

_uetMSclkID	90 days	Used to capture the Microsoft Click ID from the ad URL in order to improve conversion tracking.	Microsoft
_fbp	90 days	Used by Facebook to deliver a series of advertisement products such as real time bidding from third party advertisers.	Facebook
_gcl_aw	90 days	To store ad click information (only if remarketing cookies are enabled), generate unique IDs for visitors to remember preferences and track and gather statistics and conversion rates through the website.	Google
_gcl_au	90 days	Used by Google AdSense for experimenting with advertisement efficiency across websites using their services.	Google
IDE	1 year	Used by Google DoubleClick to register and report the website user's actions after viewing or clicking one of the advertiser's ads with the purpose of measuring the efficacy of an ad and to present targeted ads to the user.	Google
ANONCHK	1 day	Registers data on visitors from multiple visits and on multiple websites. This information is used to measure the efficiency of advertisement on websites.	Microsoft
SM	Session	Registers a unique ID that identifies the user's device during return visits across websites that use the same ad network. The ID is used to allow targeted ads.	Microsoft

uids	90 days	This cookie contains a base 64 encoded JSON object which contains external unique randomly-generated values that enable other Prebid Server demand partners to distinguish browsers and mobile devices. This information is used to select advertisements for delivery	Xandr
mTrackingPageViewCount	1 day	Stores data on the page views on the website and its sub-pages, during the current session.	Google

Kontrollera och ta bort cookies

Om du vill ändra på hur en webbläsare använder cookies, t.ex. att blockera eller ta bort cookies från Ford-webbplatser (eller egentligen vilken annan webbplats som helst) kan du göra det genom att ändra webbläsarinställningarna.

För att kontrollera cookies kan de flesta webbläsare låta dig antingen godkänna eller avvisa alla cookies, godkänna bara vissa typer av cookies, eller meddela dig varje gång en sajt vill spara en cookie. Det är också lätt att ta bort cookies som redan sparats på din enhet av en webbläsare.

Processerna för att kontrollera och ta bort cookies varierar beroende på vilken webbläsare du använder.
